



# Application for Mission-Based Discounts & Need-Based Scholarships

**Application and Determination Process:** Submitted documentation will be verified by Accounting and supplied to the Scholarship/Discount Committee for final determination of awards. Student will be notified of their discount and/or scholarship amount prior to the start of the relevant program.

**Deadline:** Priority deadline for application, documentation, consideration by the committee is Monday, March 27, 2023 by 5 PM Central Time. Applications and documentation received after that date but before the quarter start date defined in the eligibility section may be considered if remaining awards are available.

**Eligibility for Application:** Registration for at least one quarter of the Year of More or application for a Wright Graduate University program is a requirement for eligibility. Discounts and Scholarships outlined below are available to students who begin the Year of More by April 21, 2023, and to Wright Graduate University students who apply, are accepted, and begin by April 27, 2023. Later start dates may be eligible for the scholarship and discount amounts offered at that time, if any.

#### **Award Amounts:**

**Mission-Based Discounts:** Individuals who qualify based on profession and submit appropriate documentation as verification receive a \$3500 discount on the full Year of More. Mission-based discounts will be prorated if enrollment is for fewer than four quarters.

**Need-Based Scholarships:** Individuals who qualify based on income and expenses and submit appropriate documentation as verification receive a scholarship of 15% to 50% on the quarters of the Year of More and/or a scholarship of 15% to 33% on any Wright Graduate University degree and certificate program for which they are enrolled.

**Combining Awards:** In cases where YOM students qualify for both a mission-based discount and a need-based scholarship, the student will be awarded the greater amount of the discount or the scholarship for which they are eligible, *not both*.

**Disbursement:** The total discount and/or scholarship amount will be divided by the number of quarters for which the student is enrolling. The award will be disbursed in equal units each quarter as a credit on the student's ledger. Should a student withdraw during a quarter in which a scholarship has been applied to the ledger, the scholarship or discount amount will be prorated according to the same percentage schedule as the refund policy.

**Maintaining Eligibility for Scholarships and Discounts:** 





**For students enrolled in only the Year of More:** Continued participation and receipt of scholarship and/or discount is dependent on abiding by the operating agreements of the program, as published in the Year of More student handbook.

For students enrolled in Wright Graduate University, including the Year of More as performative learning: Continued receipt of the scholarship and/or discount is dependent on remaining a student in good standing and abiding by the policies in the current University catalog. Scholarships for Wright Graduate University students are dependent on maintaining a 3.0 (B) average. Should a student's cumulative GPA fall below 3.0 in a quarter, they will not be eligible to receive the scholarship in the following quarter.
